## Terms & Conditions

- A. Exhibitors and Registrants (hereinafter also referred to as Applicant) shall be bound by the conditions, rules and regulations set forth in this agreement and any changes must be made in writing and signed by an authorize signatory of ITE (hereinafter referred to as Organizers) who shall have full power to interpret and to make or amend these rules provided that such amendments and additions do not operate to diminish the right reserved for the Exhibitors / Registrants under this Contract / Application and shall not operate to increase liabilities of its Sponsors, Agents or Employees.
- B. No Exhibitor shall be permitted to exhibit or be provided with possession of the space, unless he has paid prior to the exhibition all of the fees as agreed as per the payment schedule & procedure given on the reverse side.
- C. Rights of an Exhibitors shall not be assignable to any other firm, entity or person and exhibitor shall not assign his space or sublet the whole or any part of the space contracted for, under any circumstances
- D. Exhibitor shall not obstruct the view of adjoining exhibitor nor to operate in any manner objectionable to other exhibitors. All lighting within the exhibition booth must be arranged and operated so as not to be distracting to adjacent exhibitor. Photograph, radios or other sound devices operated in a manner objectionable to the Exhibition Committee shall be not be permitted,
- E. Exhibitor shall not permit raffles donations or other promotional measures that requires members or guests to be present at a specified location and time, and the Exhibition Committee must approve all unusual promotional plans in advance.
- F. Attendance hours shall be controlled solely by the Exhibition Committee who will specify hours etc. and admission shall be by ticket or badge and identification badges shall not be transferable.
- G. No Exhibitor will be allowed to remove his exhibit from the Exhibition floor prior to the official termination of the Exhibition. The Exhibitor shall have an authorized representative present at the Exhibition throughout the Exhibition period and during the installation and dismantling of his exhibit and will solely be responsible to take care of their own exhibits and / or belongings.

- K. The exhibitor will submit list of inventories, materials, exhibits to be displayed or sold. The exhibitor will also maintain records like invoice / GST Number etc. of sale at all times during the exhibition for verification by the competent authorities and further undertakes to pay the statutory taxes / dues, if any to the said authorities. The exhibitor acknowledges and undertakes to give full sale figures etc. with details and will clear all dues of the organizers/authorities before leaving the premises by taking an out gate pass /Exit Gate Pass from the organizers / competent authorities.
- L.
